## **QUERI PEC 19-001 EXTENTION**

# The QUERI PEC 19-001 "Facilitation of the Stepped Care Model and Medication Treatment for Opioid Use Disorder" is extended for an additional 2 years!!

The extension of PEC 19-001 for an additional 2 years will allow us to continue the current, very successful, external facilitation and educational programming of the SCOUTT initiative. This will afford the expansion sites opportunities to receive resources that made PHASE 1 of SCOUTT so successful. In addition, it will allow the PEC 19-001 to expand its educational and facilitation curriculum to assist existing sites to replicate their model at another site in the VISN. Thus, in FY2021 and FY2022 we wish to continue providing support to sites outside of the 18 original implementation clinics (spread sites) and continue the site visits for existing SCOUTT sites who may need that assistance.

#### Buprenorphine Formulations for Chronic Pain Management March 2020

The new VA Recommendations for Use (RFU) document is intended to provide guidance on the use of buprenorphine, in it's different formulations, for pain management, including for patients at high risk from other opioids due to medical or mental health factors and specifically also for patients who have comorbid Opioid Dependence (as defined by ICD-10) or OUD and chronic pain conditions.
